- Student has a G.P.A. of 3.0 or higher (Must include official transcript)

- Student understands they must be present each day of the FAIT program and they will be responsible for their transportation to and from the FBI Tampa Division. (FAIT program hours are 8:00 a.m. to 4:00 p.m.)
